
Dorset Council seeks to achieve an average of over 30% affordable units in any new housing development. In fact their average is 17%.



## What's going on...?

Developers often avoid building affordable/social housing in their developments. They claim it would make their whole scheme 'financially unviable'. The 5 acre Dorchester Prison site, which will have no affordable/social housing, is a classic example. To avoid the legal fees associated with an appeal by developers, Dorset Council rarely challenge this practice.

This is critical. The proposed 4,000 new houses to the north of Dorchester will, if the development goes ahead and follows this trend, build thousands of houses we don't need, and very few houses we do. The proposed scheme would be 25% bigger than Poundbury. It will create high-cost housing, second homes and massive profits for the developers and land owners while depriving our town of the reasonably priced housing it desperately needs.

#### '...25% bigger than Poundbury...'

Apart from the climate and environmental damage to the area, increased strain on already creaking infrastructure and the loss of agricultural land, it would just be more of the same pandering to developers' and land owners' greed.

Affordable/social housing is what Dorchester needs. There are brownfield sites, such as Charles Street, available within the town. It's time Dorset Council championed their voters' needs and insisted that all these sites are used, instead of destroying the beautiful downland north of Dorchester.
